They are the victims of human trafficking. We, the family members of the victims, are gravely concerned about them. We want them to get justice in what has been a terrible ordeal for all of us.

Your presence at the hunger strike site and your help would make their struggle bearable.

We would also like to strongly urge you to write to the Attorney General Michael. B. Mukasey ,the Director of the Department of Justice to let him know about the urgency of the situation, and take reasonable actions to grant CONTINUED PRESENCE for the Indian workers so that they can participate in their struggle for justice.

We personally request you to express your solidarity with the hunger strike.
